

## Contributor License Release Form

**Purpose of this form:** In an effort to promote the sharing of resources and best practices in medical education across the Faculties of Medicine, the AFMC centralizes the collection of resources, learning materials and platforms provided by members. If a contributor intends to share resources or work that is not open access, they must grant the AFMC permission to include their contributions as outlined below.

**Parties and Terms:** The following is an agreement between The Association of Faculties of Medicine of Canada (“AFMC”), whose head office address is 10<sup>th</sup> Floor – 150 Elgin Street, Ottawa, Ontario, Canada, K2P 1L4, and you - any person or other legal entity, and in the case of persons under the age of majority, their parent or legal guardian, (“you”, “your” and the “contributor”) who wishes to contribute any material, including resources, programs and learning objects (“User Content”), and the service provided on the Site (the “Service”).

**License Grant:** By posting, transmitting, or sharing of Service User Content, whether generated by you or third parties, to any part of the Site, you automatically grant, and you represent and warrant that you have the right to grant, to the AFMC, a non-exclusive, transferable, royalty-free and fully paid, worldwide license (with the right to sublicense) to use, copy, publicly perform, publicly display, reformat, excerpt (in whole or in part) and distribute such User Content for any purpose reasonably connected to the operation of the Site or the promotion thereof, to prepare derivative works of, or incorporate into other works, such User Content in conjunction with the operation of the site, and to grant and authorize sublicences of the foregoing.

**Sponsored or Supported Work:** If the User Content is based upon work that has been sponsored or supported by a university, agency or organization other than the AFMC, you represent that you have fulfilled any right of review or other obligations required by the agreement with such sponsor.

**Removing Content:** You may remove your User Content from the Site at any time. If you need assistance, please contact us at the technical support contact information available on the Site. If you choose to remove User Content, the license granted by you to the AFMC in this agreement will automatically terminate with respect to the removed User Content, except that the AFMC may retain a copy of your removed User Content for archival and record keeping purposes only for as long as the AFMC chooses. The license granted by you to the AFMC with respect to any User Content that remains on the Site that you have not removed will continue in perpetuity.

**Authorship and Liability:** The AFMC will clearly identify the authorship, as provided by you, of the User Content and will not make any alteration, other than as allowed by this license, to your content. You agree to indemnify and hold the AFMC harmless from any liability it may incur for accepting your User Content or for maintaining your User Content on the Site.
