Note: The results presented in these data tables are based on the responses of a self-selecting sample from a census of MD students eligible to graduate from a Canadian faculty of medicine as of January 2025. These responses should not be extrapolated to the entire medical student population. Comparisons to the Association of American Medical Colleges' (AAMC) Canadian Graduation Questionnaire (CGQ) data from previous years cannot be made due to changes in the content of the questionnaire, as well as the method of administration. Percentages may not add to 100 due to rounding.

Introduction

The AFMC is pleased to present the AFMC Student Questionnaire Class of 2025 – Graduation Questionnaire (ASQ – GQ) National Report. The ASQ GQ is the result of the collaborative effort of medical educators, representatives from Canadian faculties of medicine, delegates of the Committee on Accreditation of Canadian Medical Schools (CACMS), students, and residents, supported by AFMC staff. The ASQ GQ is part of the AFMC Student Questionnaires (ASQ) series of surveys.

The goal of the ASQ suite is to survey MD students at the most appropriate times during their MD journey. Learners are asked about their experiences upon entry with the MD Entry Survey, before clerkship with the Pre-Clerkship Survey and at the end with the Graduation Questionnaire. Learners are also asked to describe their experiences in their own words.

This report captures data obtained from the Graduating cohort of 2025 and concludes the AFMC Student Questionnaire (ASQ) cycle that started in 2021 (or 2022 for 3-year schools) for undergraduate learners. Most faculties are already participating in all three surveys to provide a complete picture of the learner's journey through their program. AFMC is collaborating closely with the faculties who are not yet participating and proposing ways to accommodate their transition to ASQ. For the faculties already participating, reports similar the GQ reports have been generated for the MD Entry and Pre-Clerkship surveys and a cohort report is under development.

Data Collection and Reporting

The target population for the 2025 AFMC GQ was the 2,637 students who were registered in active studies and, as of January 2025, eligible for graduation from their MD program at one of the following participating Faculties of Medicine: Dalhousie University, McGill University, McMaster University, Memorial University of Newfoundland, Northern Ontario School of Medicine, Université de Montréal, Université de Sherbrooke, Université Laval, University of Alberta, University of British Columbia, University of Calgary, University of Manitoba, University of Ottawa, University of Saskatchewan, and Western University.

The 2025 AFMC GQ was available in English and French between February 17, 2025, and April 28, 2025. Eligible students were e-mailed a unique, private link to gain access to the online survey. This customized URL was automatically generated by the online survey platform. Neither the AFMC nor the schools can link a student to their URL. In this way, participants were ensured anonymity.

A questionnaire was considered completed if a respondent consented to the terms of the questionnaire and submitted the questionnaire. We received 1,296 completed questionnaires, for a national response rate of 49.1%.

To uphold rigorous standards of participant anonymity and the confidentiality of responses, only aggregate data are reported by AFMC. The AFMC produces a publicly available national report, combining data from all schools. Each faculty is also provided with a report that aggregates responses at the faculty and, if applicable, campus levels. These reports are not publicly disseminated by AFMC. No report is issued if there are fewer than 10 respondents for that reporting level (e.g., if a campus has fewer than 10 respondents). Faculty response rates ranged from 13% to 90%.

Responses to questions about finances or research experience could, on their own, reveal information about the identity of a respondent. For this reason, no results are reported when fewer than 5 respondents selected a response option for these questions.

Individual-level data will not be made publicly available by the AFMC. Clean and de-identified data are available to participating faculties upon request.

Interpretation of Results

Results obtained are not based on a random sample and respondents were self-selecting. For this reason, extreme caution must be applied when performing comparisons or drawing conclusions based on this non-random sample.

When appropriate, standard deviations of the results are presented. This statistic is useful to assess the distribution of the answers to a question. The standard deviations in this report are not meant to be used to build confidence intervals or infer statistical significance.

Selected Findings

More students agree to have been appropriately trained to care for individuals from diverse backgrounds.

When asked if they were appropriately trained to care for individuals with diverse backgrounds, 91.3% agreed (53.4%) or strongly agreed (37.9%). An increase from 87.6% in 2024 and 84.8% in 2023.

More students feel prepared for residency.

When asked if they were confident that they had developed the clinical skills required to begin a residency program, 96.9% of students agreed (50.8%) or strongly agreed (46.1%). An increase from 95.0% in 2024 and 2023.

The number of students who have participated in a research project or other scholarly activity with a faculty member has decreased.

When asked if they had participated in a research project or other scholarly activity with a faculty member, 74% had indicated yes. A decrease from 77.2% reported in 2024 and 80.7% reported in 2023.

Fewer students have reported experiencing any of the listed forms of mistreatment during their medical education.

When asked whether they had personally experienced any of the listed mistreatment behaviors during their medical education journey at least once, 54.9% of respondents in 2025 indicated that they had. This is a decrease from the 60.7% reported in 2024, but consistent with the 54.7% reported in 2023.

More students are satisfied with programs/activities that promote effective stress management, a balanced lifestyle and overall wellbeing.

When asked how satisfied they were with programs/activities that promote effective stress management, a balanced lifestyle and overall wellbeing, 76.9% were satisfied (56.9%) or very satisfied (20%). An increase from 70.6% reported in 2024 and 67.8% reported in 2023.

When it comes to responsiveness to student problems, more students are satisfied with their Office of Student Affairs/Student support services team.

When asked to indicate their level of satisfaction with their Office of Student Affairs/Student support services team in responsiveness to student problems, 67.3% of students indicated being satisfied (47.5%) or very satisfied (19.8%). An increase from 63.6% in 2024 and 61.8% in 2023.
